modification programs. Thank God for
my parents raising our kids. I will
say my parents and kids saw me
trying to break a way from him and
the drugs. ^{we} went on a chime speaker
all along I-75 convictions in KY
~~an TN then lastly Florida against~~
we were co-defendants in St John's
County he got 24 mos 5 yrs probation
I got 32 mos 5 yrs probation. I vowed
to go home do my life and be there
with those who were there for me.
When Mike was released he was
extradited to KY my dad paid his
restitution offered him a fresh start
with his kid instead he took cash
for a bus ticket. When I got out
June 2012 he was still on probation
I transferred mine to Ohio and
went to work while Mike kept
violating probation I paid off both
of our probation or he would still
be on it it was joint & severed
He also fled his P.O. down there
and came here till he could pay

off his 4th probation to get off of it. He smoked crack every day and upon his departure him and his new wife stole my son's (24) TV for \$ 20 in crack and told us we could go buy it back. His wife was on surveillance video in the pawn shop with Mike he's not good at working alone. I saw testimonials of people he robbed and my children and I got sick. He isn't going to stop it's sad to say no one or nothing was packed. The longest time he has done is 2 years. This to him is easy time and worth whatever Hugh he and Susan had. Again I went through this 10 year cycle. I got off probation worked up the marks in my job haven't had as much as pulled over by law enforcement I am having great relationship with my kids and my 85 year old parents. To my knowledge he even stole tools from Rainey Construction but his wife disposed of I didn't mean to take too much of your time

but Mike says your easy prey.
He talked to me up until 12-16.
He has it all planned out.
He will seek out weak or elderly
he doesn't just steal he is an official
con man and total narcissist

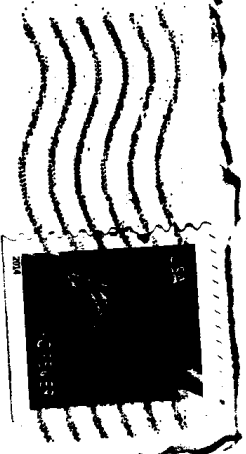
